Course Description:

This course will focus on the fundamentals of International Law – the nature, history, theoretical foundations, and the actors and entities that execute, uphold and maintain International treaties, codes and conventions (states, international organizations, non-governmental groups, corporations, etc.). We will explore the Law of the Sea, a specialized area of International Law pertaining to use and control of the sea / seabed and its resources and the relationships among states that desire to exploit these resources.

The course will also include review of international codes and conventions that pertain to the mariner – seafarers. This includes the major IMO conventions: Safety of Life at Sea (SOLAS), the International Convention for the Prevention of Pollution from Ships (MARPOL) and Standards for Training, Certification and Watchkeeping for Seafarers (STCW). We will also discuss the International Labor Organization's Maritime Labor Convention – MLC 2006, Ballast Water Convention and corresponding U.S. domestic regulations implementing the international conventions.

Grade Computation:

Quizzes, Exams and Projects: Grades will be based on quizzes, exams and projects as well as class participation and attendance. The mid-term exam, mid-October will be worth 30% of final grade and the Final Exam will be worth 40% of final grade. Course Learning Objectives:

1. An understanding of the history, development and scope of International Law; knowledge of how International Law is created, interpreted and enforced; and a clear understanding of how international disputes are resolved;

2. A basic working knowledge of the relevant IMO conventions concerning safety of life at sea, security and protection of the marine environment; and an understanding of related international maritime conventions and recommendations, as well as related, applicable U.S. domestic regulations.

Course Learning Outcomes:

1. Students should have a thorough understanding of how international law is created, interpreted and enforced; and a clear understanding of how international disputes are resolved.

2. Students should have a thorough understanding of international agreements and theories and practices of states within the international community.

3. Students should have a thorough understanding of how international law applies to marine professionals.

4. Students should have a thorough understanding of relevant IMO conventions, related international maritime conventions, as well as national legislation.

Social Science Learning Outcomes:

1. Higher order thinking: Students should be able to perform higher order thinking skills to include both critical and insightful thinking. They should be able to apply the elements of reasoning and be able to use criteria and content in order to make decisions, analyze arguments, imagine solutions to problems and create original and unique scholarship.
